New Business:

Randy Boyd made a motion to approve the Minutes from the Vestry Meeting of July 2nd.
The Vestry voted 9:0:0 to approve the Minutes.

Treasurer's Report:

- Dorene presented the Treasurers report through August 2014.
 - o August, Actual versus Budget
 - Revenue of \$11,737 versus a budget of \$17,646
 - Expenses of \$11,535 versus a budget of \$18,247
 - o YTD, Actual versus Budget
 - Revenue of \$137,070 versus a budget of \$141,164
 - Expenses of \$135,932 versus a budget of \$145,044
 - o FY 2014 Forecast versus Budget
 - Forecasting 2014 Income of \$226,673
 - Forecasting 2014 Expenses of \$220,027
 - 2014 Results are dependent upon special events producing approximately \$12,000 through the remainder of the year.
- Archer made a motion to approve the 2010, 2011 and 2012 Audit report prepared by Harris Hardy & Johnstone, Inc. The Vestry voted 9:0:0 to approve the Audits.
- Rob Erda has been asked to chair the 2013 Audit Committee. Rob has agreed to chair the Audit Committee with help from Monica Bowling and Jinx Zygeti.
- Randy Boyd made a motion to give authority to Alice Tyler (Books Keeper) to pay recurring monthly expenses that are within 125% of the average monthly budget. (For example, if 2014 telephone budget is \$1,200, \$100 per month, Alice can pay a phone bill up to \$125 without approval). The Vestry voted 9:0:0 to give Alice this Authorization.
- Archer made a motion to approve the August 2014 Treasurer's report. The Vestry voted 9:0:0 to approve the August 2014 Report.

Rector's Report:

- April reported that she sent a letter to the church community outlining upcoming events; including: The Holiday Bazaar and the visit of Bishop Ted Guliak on October 5th.
- Bishop Ted Guliak will attend the October 5th. There will be only one **service at 2:00 on** the 5th with a reception to follow. No 8:30 or 10:30 service.
- Several new members have joined the Church.
- April reported that a disproportionate number of church members have had family crisis in recent week. April has been spending a lot of time supporting these people.
- EFM: Westover is working hard to get people involved with EFM. Rusty Copeland is leading that effort.
- Greg is working hard to get more members of the Congregation involved in the music.

Senior Warden's Report:

• Archer reported that he was very happy to see strong attendance in church through the summer.

Junior Warden's Report:

- Jimmy reported that there have been many small repairs in recent weeks (toilets, sinks, hinges, keys, etc.)
- We are evaluating the quality of cleaning that is being provided by our cleaning service.
- Amy our tenant plans to move out October. Jim Daniels has several prospects. A motion was made to give authority to the Junior and Senior Warden to execute a satisfactory lease. **The Vestry voted 9:0:0 to give approval to the Wardens**.

Other Business:

- April has been asked to send a Thank You note for the bequest from the Hull Estate (\$10,000).
- A Harvest & Holiday Bazaar will be held Saturday, November 8th from 9:00 2:00.
 - Peggy reported that a letter has been sent to all Charles City church to rent tables for the Holiday Bazaar. No churches have been heard from;

 - o Food will be served. Brunswick stew is on the menu.
